 - ✓ Indonesia and Japan have G-G cooperation that may be used as the source of funding. (Agus Purwadi)

- ✓ Indonesia Ministry of Education also has Researchers Exchange Program but to be eligible for that program, the exchange period should be at least 3 months and the researcher qualification should be Ph.D. (Agus Purwadi)
- d. Thailand requirement is not similar to Indonesia requirement.
 - ✓ Thailand need JARI researcher to be dispatched to Thailand first. Later, Thailand researcher could be trained at JARI facility. (JARI do not have researcher dispatch program, and is going to study it.)
- e. EV related program
 - ✓ Indonesia and Thailand interested in the program but different schemes are applied.
 - ✓ Fuel cell battery is not yet needed right now for Thailand.
- f. ISO26262
 - ✓ CAERI like to have further discussion in ISO26262, and the program starting time is to be studied. CAERI will send about 1 or 2.
 - ✓ For Indonesia side, it will be do ne if the fund is available.
 - ✓ Thailand has not yet needed the ISO26262.
- g. CNG Conversion Program
 - ✓ Only Indonesia interested in the program.
 - ✓ CAERI also produced CNG conversion product, therefore does not Interested in the program.

 - Researchers Exchange means exchange among institution. Not JARI centralized. Flexible researcher exchange is possible. It needs information exchange among institution to inform where is strength points of one institution and where is it s weak point.
 - ✓ Possible funding source is from international financial organization, in addition of G-G financial assistance.
